THE WINNER FROM EACH GROUP WILL GO FORWARD TO THE SEMI-FINAL. IF THERE IS A TIE FOR THE WINNER OF THE GROUP, THE PLAYER WITH THE GREATER TOTAL SHOT DIFFERENCE WILL PROGRESS TO THE SEMI-FINAL. EACH GAME IS 4 WOODS AND THE WINNER IS THE FIRST TO SCORE 21 POINTS. IF YOUR NAME HAS BEEN PICKED FIRST THEN YOU ARE THE CHALLENGER AND WILL NEED TO ORGANISE A MARKER.
